## RTI - Third Party Audit - National Institute of Wind Energy (NIWE), Chennai

## **Summary Report**

All the public authorities should proactively disclose the information under the Right to Information Act, Section 4, which will help bring transparency in the administration. We appreciate the sincere efforts of the National Institute of Wind Energy (NIWE), Chennai as a Public Authority for sharing required information on the website to maintain transparency.

During Auditing it is observed that the information related to few areas have to be shared on the website:

- Pay scale of employees need to be clearly mentioned for understanding of public under List of employees with Gross monthly remuneration.
- Particulars of facilities available to citizen for obtaining information is missing the working hours of facility under RTI section 4(1)(b)(xv).
- Information in regards to the programmes to advance understanding of RTI (Section 26) needs to be conducted and published in the website. Also, it has to be held on a regular basis at frequent intervals.
- Information related to e-Governance specific to Vernacular/Local language needs to be published in the website. Bilingual is currently available.
- Committee need to be formed for consultancy of key stake holders for advance on suo-motu disclosure and also, constitute the committee of PIOs/FAA with rich experience in RTI to identify frequently sought information under RTI.

It is suggested that the Public Authority of National Institute of Wind Energy (NIWE), Chennai, may take necessary action to disclose the above discussed information on the official website as per the Section 4 of the RTI Act.
